Pursuant to Vehicle and Traffic Law section 1802(2), you may be permitted to pay any fines, fees or surcharges via a monthly installment payment plan when you are 1) convicted of a Vehicle and Traffic Law offense or 2) convicted of a local law, ordinance, order, rule or regulation related to traffic. The judge sets the monthly payment amount. The minimum

payment is \$25/month or up to 2% of your net monthly income, whichever is higher. No additional charges or interest are added. You may be required to submit a Financial Disclosure Report to get an installment plan. You may be required to appear in court no more than once per year for the judge to assess your financial circumstances, and your monthly payment amount may increase or decrease if your income changes. You can ask the court to reduce your monthly payment amount no more than twice per calendar year if your income decreases.
